### **My Morning Out – Discipline Policy**

THE STATE OF ILLINOS REQUIRES ALL CHILDCARE CENTERS TO POST THEIR DISCIPLINE POLICY AND NOTIFY EACH TEACHER OF THAT POLICY. PLEASE READ OUR DISCIPLINE POLICY BELOW AND SIGN TO INDICATE THAT YOU HAVE DONE SO.

Discipline/Guidance Procedures: The My Morning Out, NFP approach to discipline is guided by the Creative Curriculum for Infants, Toddlers, Twos and Preschoolers. The physical environment is designed to create a place where children can grow and learn; conflict management is part of the daily routine, and a natural part of the day-to-day activities. Staff members are trained to help children work through the daily conflicts that occur when groups of children are together in a childcare setting.

When a specific situation arises, the teachers will use redirection to resolve conflicts over toys, taking turns, and during transitions. DCFS permits the use of “Time Outs” for children over two years of age. However, MMO does not encourage the use of “Time Outs” in our classrooms.

When a child is part of a conflict resulting in an injury an Accident Report is filed, and signed by the director. The parent will be notified at pick-up time, unless teachers feel immediate notification is necessary.

It is not appropriate for MMO Staff, the Director, or members of the MMO Board to share any information regarding incidents, or behavior management plans for any child other than their own.
